## Traditional Account Option

### Distribution Option

No distribution without a court order.

Account assets are not protected from third party claims or creditors.

Government benefits and financial aid eligibility are reduced.

## C<sup>3</sup>BR Account Solution

### OPTION 1: Distribution Option

One or more age based distribution events without further order from the Court.

### OPTION 2: Preauthorized Distribution at Specified Ages(s)

Court preauthorizes the trustee to make distributions upon the Beneficiary obtaining one or more specified age(s).

Up to 5 specific age-based distributions allowed.

Example: \$30,000 funding Distribution(s) scheduled as follows:

- AGE 18 \$5,000
- AGE 25 \$10,000
- AGE 30 \$15,000

Note: Accumulated interest is disbursed with the last scheduled distribution.

\* See notice option.

### OPTION 3: HEMS Restricted Distribution Option

- Health
- Education (includes summer camps)
- Legal
- Support & Maintenance

Above distributions are subject to the following stipulation limits as ordered by the Court:

- Single distribution limit
- Combined distribution limit
- Combined annual distribution limit

### Notice Option

Written notice is mailed upon the Beneficiary obtaining each specified age.

If the Beneficiary does not respond with a request to withdraw within 90 days of the notice, the unrequested DISTRIBUTION SHALL be deferred until the next specified age.

In the event the distribution is the sole remaining distribution; written notice to the Beneficiary will be provided annually until such time the Beneficiary requests a distribution.

**BENEFICIARY RETAINS THE RIGHT TO PETITION THE COURT FOR ADDITIONAL OR ALTERNATE DISTRIBUTION(S)**
